## COUNTERFEITING - An Australian perspective:

Why the counterfeiters are winning and what can be done about it



The Government announced that it would provide funding of \$12.4 million over the next two years to strengthen the capacity of the Australian Federal Police and the Commonwealth Director of Public Prosecutions to take enforcement action against intellectual property crime.
